**ORAL AND WRITTEN COMMUNICATIONS**

- Alexander Fung speaking as Chair of the City’s Economic Development Advisory Commission (EDAC) offered to collaborate with the Environmental Commission on SB 1383 – methane emissions reduction. The law will have a significant impact on how the City manages its food waste. Chair Fung is also the Management Analyst for the San Gabriel Valley Council of Governments (SGVCOG).
- Jennifer Fan, a Monterey Park resident, voiced concern about the increase in plastic waste generated by takeout and delivery of prepared food due to the pandemic. She recommended that the city consider an ordinance that requires restaurants to only provide plastic utensils for takeout orders when requested.

**3. OLD BUSINESS**

**3-A. MONTEREY PARK EARTH DAY**

Chair Wong described the changes to the Earth Day event due to the pandemic. The event will be a partnership with the Bruggemeyer Library and the Asian Pacific Islander Forward Movement (APIFM) for a virtual event on April 19 at 3:00 PM.

**3-B CLIMATE ACTION PLAN REVIEW**

Chair Wong informed the Commission that he received an update from the City’s Planning Manager Jason Moquin and the Public Works Director Frank Lopez on the status of the review of the City’s Climate Action Plan. Updated Land-use and Housing Elements of the General Plan have to be completed before the City is eligible to apply for grants. The Land-Use component has been completed and approved, and the Housing element is expected to be finished in 16 months – it was started last year. Chair Wong recommended that the Commission continue to request updates from the Public Works Director and Planning Manager.

Commissioners Ko and Chan expressed their concern that the City is not taking advantage of the numerous grants. They requested that the City hire a grant writer.

He is most proud of the Commission's annual Earth Day and Bike Ride event. He recommended that the Commission continue to get involved in the Climate Action Plan and to undertake pressing issues such as the upcoming drought, energy and transportation programs that can address Greenhouse Gases and how the City can move forward in the post pandemic era.
