1-A. RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE MONTEREY PARK FIREFIGHTERS' ASSOCIATION FOR THE TERM OF JULY 1, 2023 TO JUNE 30, 2025

- (2) Taking such additional, related, action that may be desirable.

1-B. APPROVE THE NOTICE OF PUBLIC HEARING FOR WATER AND SEWER RATE ADJUSTMENTS AND SET A PUBLIC HEARING DATE ON DECEMBER 6, 2023

- (2) Establish proposed water and sewer rates for customer consideration;

- (4) Set a Public Hearing to consider rate increases; and
- (5) Taking such additional, related, action that may be desirable.
