## California Environmental Quality Act (CEQA):

An Initial Study and a Mitigated Negative Declaration were prepared and were made available for public review from March 16, 2021 through April 14, 2021. With the implementation of certain mitigation measures, the proposed Project will not have a significant impact on the environment and therefore a Mitigated Negative Declaration (MND) with Mitigation Measures and Mitigation Monitoring and Reporting Plan (MMRP) is recommended for adoption.
